

CONCURRENT ADMISSION FOR HIGH SCHOOL STUDENTS

To be admitted as a concurrent student, you must:

- 1 Complete the online concurrent application.
- 2 Submit your official high school transcript reflecting unweighted GPA and class rank (if available).
- Submit a signed concurrent approval form from your high school counselor. Information about submitting the form will be available in your portal once you complete your application.
- 4 Pay the \$40 nonrefundable application fee (one time only) or submit a fee waiver.

Applicants must be on pace to satisfy all 15 high school curricular graduation requirements, which include: 4 English, 3 Mathematics, 3 History & Citizenship, 3 Lab Science and 2 Elective units.

CONCURRENT ADMISSION REQUIREMENTS

24+ ACT/Pre-ACT or 1160+ SAT/Pre-SAT OR top 33.3% rank in high school graduating class with at least a 3.0 unweighted cumulative GPA

Students must have a 19 ACT/510 SAT or better in a subject area to take a concurrent course from that subject.

Beginning with the fall 2022 term, students have the option to apply to OSU without consideration of a test score. Students may indicate on their concurrent application for admission that they would like to be considered as test optional and submit their high school transcript for review. This also applies to home school, private, parochial, or other non-public high schools which are not accredited by a recognized accrediting agency.

Students must have completed enough high school coursework to be equivalent to an individual who is classified as a junior or senior at an accredited high school.

For students applying with a standardized test score, national ACT and SAT testing is preferred for concurrent student admission. One OSU residual ACT per year may be used for concurrent admission.

COST OF CONCURRENT ENROLLMENT

Tuition Waiver: Oklahoma high school seniors receive a tuition waiver for up to 18 credit hours, starting the summer before their senior year. This tuition waiver covers only the cost of tuition. Students are still responsible for any required fees.

Fees: The fees for each course are charged per credit hour and vary depending on the course, the academic college providing the instruction and whether the course is taught at a high school or on the OSU campus. You may contact the Office of Concurrent Programming and Advisement at 405-744-1393 to help you with course selection and estimate the accompanying fees. Oklahoma seniors qualify for a scholarship to cover fees.

Billing: Please note that OSU uses electronic billing. Students will not receive a paper bill at their home address. Bursar statements are submitted to the student's OSU email account. Detailed billing information is available at:

CONCURRENT HIGH SCHOOL STUDENTS

ASSESSMENT / COURSE PLACEMENT:

All concurrently admitted students must obtain a 19 ACT subject score(s) in English, mathematics and/or science reasoning to enroll in coursework in the respective subject area(s). Students must score a 19 or above in reading to enroll in any other collegiate course(s) outside the subjects of English, mathematics and science. Beginning with the fall 2022 term, an alternative process based on high school performance for test optional applicants will be available.

ENROLLMENT TIMELINE:

For your initial application, the Office of Undergraduate Admissions requires receipt of all documents three to five business days before you intend to enroll. This allows our staff time to process your application and have your enrollment materials prepared when you arrive to enroll.

CONTINUING CONCURRENT STUDENTS:

Concurrent students must submit a new online application and concurrent approval form for each semester they want to attend. Application fees, transcripts and test scores do not need to be resubmitted.

OSU AFTER HIGH SCHOOL GRADUATION:

If you are interested in attending OSU beyond high school graduation, you are required to complete the entire freshman application for admission/scholarships and attend an orientation and enrollment session. Please pay particular attention to the scholarship deadlines. You are not required to submit a new application fee if you have not attended another institution between concurrent enrollment and applying to become a full-time student at OSU.

OSU EARLY UNIVERSITY

OSU now offers a variety of options to take your concurrent class.

Cowboy Concurrent Online: Concurrent courses are offered online to give students across the state and beyond access to concurrent enrollment.

Eligible Oklahoma seniors receive a tuition waiver from the state and a scholarship from the OSU Foundation to cover fees. There is a one-time application fee required for admission. Oklahoma juniors receive a reduced rate of \$775 per course. Out-of-state students will pay \$300 per credit hour, or \$900 for a 3-credit hour course.

The reduced rates apply to the Cowboy Concurrent Online courses only and are based on availability. Some courses require textbooks and exam proctoring, which comes at additional costs to the student. For more information, visit **cas.okstate.edu/cowboy_concurrent**.

On the OSU Stillwater Campus: Immerse yourself in the college experience by enrolling in a course located on our main campus.

OSU in your school: OSU has departments that will send instructors to teach a college course right in your high school, and build it around your existing schedule. There is a 15 student minimum, and school districts are welcome to act as a host site for students from other schools.

Courses at Stillwater High School: Stillwater High School allows students from the surrounding districts to participate in its concurrent courses taught by OSU on the SHS campus.
