	<b>OKLAHOMA STATE REGENTS' ACADEMIC SCHOLARS (OSRHE)</b>	A five-year full tuition waiver and four-year cash award funded by the state.	Up to \$48,800 total	Based on ACT/SAT scores at or above the 99.5 percentile for OK residents. Additional criteria set annually by the State Regents. 	<b>NATIONAL MERIT SCHOLARSHIP</b>	A five-year full tuition waiver and a combination of state, university and National Merit funding. 	<b>PRESIDENT'S DISTINGUISHED SCHOLARSHIP</b>	A four-year cash award.	Up to \$2,500 per year (Up to \$10,000 four-year total)	Highly competitive selection. Requires a minimum 3.75 GPA, a 27 ACT or 1260 SAT score and a strong record of leadership as indicated on the application for admission.
	<b>PRESIDENT'S LEADERSHIP COUNCIL (PLC) SCHOLARSHIP</b>	A one-year cash award. Students serve on the President's Leadership Council.	\$1,500 total	Highly competitive selection. Requires a strong record of leadership and community service as indicated on the application for admission.

Students may only receive the award with the highest value they are eligible for from the University Assured Scholarship or Partnered Scholarship categories. Exceptions include Oklahoma's Promise and Cowboy Covenant, which can be combined with one award in the University Assured Scholarship or Partnered Scholarship categories. Students must maintain a minimum GPA and number of credit hours per semester to renew assured scholarship opportunities each year. Renewable scholarship qualifications may vary. Deadlines, figures and admission requirements are subject to change.
