United States Citizenship and Immigration Service (USCIS) regulations require documentation that sufficient financial resources are available to meet a student's prospective educational and living expenses while in the U.S. Therefore, Oklahoma State University requires a guarantee of financial resources from each applicant who expects to obtain or maintain Student (F-1) or Exchange Visitor (J-1) status. Applicants are required to submit financial documentation that equals or exceeds one full year of expenses for the program of study they are interested in pursuing. Adjustments in the financial certification cannot be made based on a student's individual circumstances. This estimate is based upon 15 semester hours each semester for undergraduate studies. A Certificate of Eligibility (I-20) will not be issued until this information is provided.

This completed form and bank certification can be submitted by email at international@okstate.edu. Students will not be evaluated or admitted to Oklahoma State University or receive an OSU Certificate of Eligibility (1-20) until this information is provided and verified.

Students who have \$35,680 in financial support are encouraged to apply for admission. Scholarships are available to international students who meet OSU scholarship criteria, but students should not rely on scholarship funds to finance their educational costs. Visit okla.st/intl-scholarship for more information regarding scholarship opportunities available at OSU. The maximum scholarship award is \$15,000 annually. The minimum estimated cost of attendance with the highest scholarship award is \$35,680. The total funds available, with personal financial support and scholarship awards, must total \$50,680 to issue an I-20.

The amounts listed below are estimates that are determined by using the cost figures for 2025-2026 academic year. The costs listed below are subject to change without notice. Historically, total costs have increased by an average of 5-10% each year. Students can expect adjustments in the amounts listed on the Certificate of Eligibility (1-20), which will reflect estimates of the possible increases in the upcoming year.
