OSU has 13,942 total employees, including 2,167 faculty.



ACADEMICS

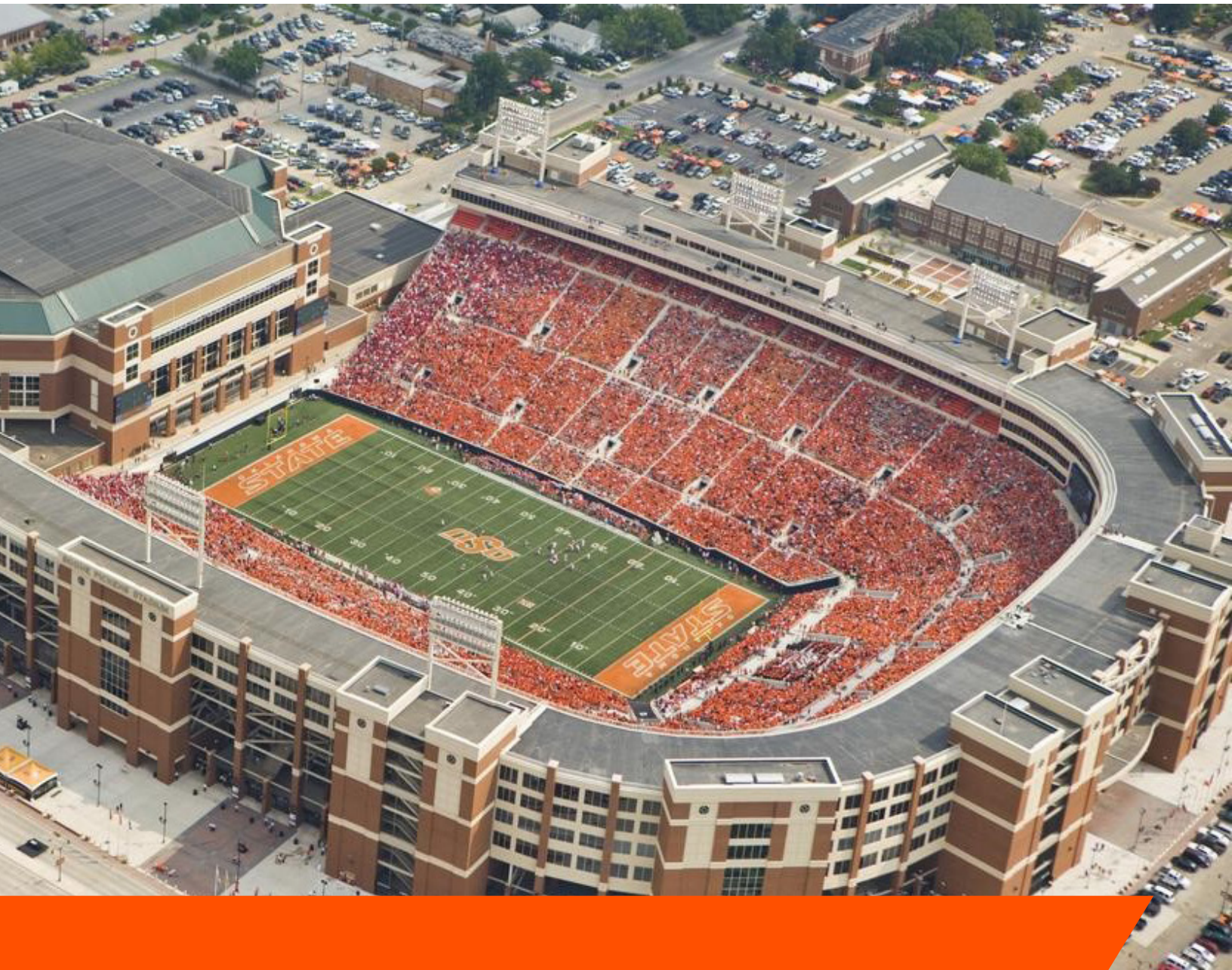

The OSU Foundation is a tax-exempt 501(c)(3) non-profit corporation under the management of an independent Board of Trustees that operates to exclusively benefit Oklahoma State University and its students, alumni, faculty and staff. The Mission of the OSU Foundation is to unite donor and university passions and priorities to achieve excellence.

OSU Foundation's vision is to become the best-performing land-grant university foundation in the country when measured by investment performance, growth in private support and operating efficiencies while maintaining outstanding donor and university relations as measured by client satisfaction.

The President of Oklahoma State University plays an active role in Board of Trustees meetings for the Foundation and is responsible for establishing the short and long-term development priorities for the organization.





UNIVERSITY LEADERSHIP

The President reports to the Board of Regents for the Oklahoma Agricultural and Mechanical Colleges. The Board, also referred to as the OSU/A&M Board of Regents, consists of nine members, one of whom is the President of the State Board of Agriculture. The remaining eight members are appointed by the Governor, by and with the advice and consent of the Senate. Except for the President of the State Board of Agriculture, Board members are appointed for eight-year terms to numbered positions on the Board representing Congressional Districts One through Five and three at-large appointments.

THE PRESIDENT

In accordance with policies set forth by the Board, the President provides overall leadership and direction for the University and components of the OSU System, hereafter referred to as OSU.

THE PRESIDENT IS EXPECTED TO:

- provide the vision and leadership needed to ensure that OSU anticipates the changing needs of society and responds quickly and effectively to those needs;
- work with a wide range of internal and external constituencies to develop and address priorities and strategic objectives which build on OSU's strengths and opportunities and are consistent with the mission, role, and scope of OSU;
- implement processes that ensure the efficient, effective, and responsible use of OSU's human, financial, and physical resources;
- nurture excitement and excellence in academic endeavors and reward intellectual achievement and service to the mission of OSU;
- position and create awareness of OSU as a leader with respect to growth, economic development, and enhancement of the quality of life within Oklahoma;
- be an effective ambassador to represent OSU to alumni and general public, business and government leaders, and the State Regents for Higher Education;
- take a proactive role in the generation of state, federal, and private funding needed to produce excellence in instruction, research, and extension/public service;
- play an interactive and visible role in the activities of OSU, seeking and effectively utilizing input from faculty, staff, students, and alumni on critical issues;
- embrace, expand, and harmonize the spirit of community and loyalty shared by all OSU constituents.

Oklahoma State University and the OSU System seek a President who can lead the total organization to a position of preeminence in undergraduate and graduate learning, research, and public service. The University and OSU System are hereafter referred to as OSU.

- has an earned doctorate/terminal degree or significant recognition, prestige, and credibility for intellectual achievement in his/her profession;
- understands critical issues and trends in higher education, including those that respect and uphold the mission and the evolving role of the modern comprehensive land-grant university;
- senses the dynamic implications of problem areas, thinking beyond problems to solutions;
- understands and will nurture an academic environment that fosters creativity and scholarship;
- will promote excellence in all programs and the recruitment and retention of outstanding talent from diverse intellectual, cultural, and socioeconomic backgrounds;
- will encourage creative and responsive approaches to developing a distinctive character for OSU;

A DYNAMIC, ARTICULATE, AND INFLUENTIAL ADVOCATE WHO

- understands the most important constituency of the University is its students;
- communicates ideas in a clear and effective manner and who projects a positive image;
- conveys persuasively a vision of research, education, and service that inspires and motivates others;
- has the social and political acumen to build confidence and trust with higher education, elected officials, alumni, and the people of Oklahoma, the Nation, and the World;
- can help OSU attract the public and private resources needed to carry out its mission with high effectiveness;
- can work in partnership with the OSU Foundation and OSU Alumni Association to lead an effective comprehensive campaign;

- has a record of success in a comprehensive academic institution or an organization of similar complexity;
- is experienced and effective in planning, setting priorities, and accomplishing goals;
- is committed to the principles and practices of diversity, inclusion, equity, access, and equal opportunity at all levels;
- has the ability to lead and manage through a process of delegation, team-building, and empowerment;
- supports processes essential to effective decision making in higher education;
- understands the increasing role of technology in fulfilling the mission of the University;
- has demonstrated ability to align and execute academic and business activities consistent with the University strategy;
